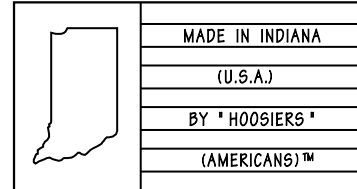


LIMITED WARRANTY

HOW LONG IS THE PERIOD OF COVERAGE?

THE WARRANTY REMAINS IN FORCE FOR 90 DAYS FROM THE DATE YOU PURCHASE YOUR *Rig Skirts™* PRODUCTS.

WHO DETERMINES LIABILITY UNDER THIS WARRANTY?

WE WILL INSPECT THE PARTS AND DETERMINE IF THEY QUALIFY FOR COVERAGE ACCORDING TO THE TERMS AND LIMITATIONS OF THIS WARRANTY.

WHAT IS NOT COVERED IN THIS WARRANTY?

LOSS OR DAMAGE DUE TO IMPROPER MOUNTING, ROAD HAZARD, FIRE, THEFT, COLLISION, NEGLIGENCE OR MISTREATMENT. LIABILITY IN ALL CASES IS LIMITED TO THE PURCHASE PRICE PAID FOR THE PRODUCT.

ONE PIECE TANDEM FENDERS ARE NOT COVERED UNDER THIS OR ANY OTHER LIMITED WARRANTY.

HOW DO I GET DEFECTIVE PARTS REPAIRED OR REPLACED?

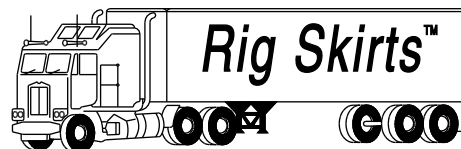
